



We are thrilled to have your support as an exhibitor at our 1st state-wide FAMILY EDUCATION EVENT with a planned attendance of approximately 225 Missouri families living with rare disease or chronic illness causing special medical needs. Our day will also include organizers, volunteers, legislators, city and state Emergency Service personnel along with other organizations and exhibitors.

The following terms will be agreed to by EXHIBITOR at time of registration submission.

Exhibitor Registration and Admittance: All personnel working at the Exhibit Table must be registered and Exhibitor badges will be provided. One Representative from each company/organization may attend the adult education sessions.

Exhibitor Table Assignment: 6 foot tables are provided. We will assign all Exhibit Table space based on the sponsorship type. Standard Vendor space will be assigned in the order the registration is received. Exhibitors requesting non-profit table space must be a non-profit status (501(c)3 or government entities) filing a 990-N or 990-EZ the previous tax year and verification provided.

<u>Company Description</u>: All Exhibitors will be asked to provide corporate name and logo as they want it to appear in all written materials and websites. Also to provide ads based on the size corresponding to their sponsorship type as listed in the Exhibitor Information. These will be emailed to: darlene@dannysdose.com

<u>Care of Exhibit Space</u>: Exhibitors are responsible for properly maintaining their space. No part of an exhibit, signs or other materials may be posted, nailed, taped or otherwise affixed to walls, doors, or floor surfaces in a way that will mark or deface the premises. Exhibit display materials cannot block the view into the adjacent table space. Exhibitors are responsible for any damage to the facility</u>. Exhibitors are expected to leave their space clean.


The following are strictly prohibited:

- At THE ZONE no outside food or drinks
- Use of any strong smelling items or fire sources

<u>Compliance with Law</u>: All Exhibitors, contractors, patrons, and invitees must promptly comply with all laws, ordinances, regulations and requirements and conform to the Fire Department Management Plan for the event facilities.





<u>Liability and Insurance</u>: Exhibitor retains sole responsibility for any damages, claims, losses, liabilities or expenses arising from any injury to any person or property that arises out of or is in any manner connected with the Exhibitor's participation at the event, including its indemnity obligations herein.

Exhibitor acknowledges that Danny's Dose Alliance, The Wingmen Foundation or their agents do not maintain insurance covering Exhibitor's property or activities and that it is the sole responsibility of Exhibitor to obtain insurance covering all risks and perils. Exhibitors are required to maintain general public liability insurance in an amount sufficient to cover such obligations, including event cancellation insurance.

<u>Eligibility to Exhibit</u>: The purpose of the exhibit program is to further the education, awareness, support, networking, and connecting of individuals in the rare diseases community. Therefore, the exhibits must be of an educational or awareness application that emphasizes networking, products, or services for use in research, treatment, or diagnosis, of relevance to the interest of the attendees. The event Hosts reserve the right to deny exhibit space or to close exhibits or parts of exhibits that reflect unfavorably on the character of the hosts. This applies to displays, literature, advertising novelties, souvenirs, conduct and attire of persons, etc.

<u>Enforcement of Rules</u>: Exhibitor agrees to adhere to all conditions and regulations outlined in this Exhibitor Terms, Conditions, and Rules, and thus is granted a terminable license to exhibit, subject to all of the rules and regulations contained herein. Exhibitor accepts responsibility for ensuring compliance from all employees and any other representatives who are acting on behalf of exhibitor. The hosts reserve the right to terminate this license and close the exhibit should any exhibitor fail to comply.
